Dear Parent/Carer,

A policy governing student use of digital devices and online services applies in all NSW public schools (from 2020). This policy covers students using school owned devices, online services, mobile phones, smart watches and devices not owned by the school.

We recognise the need to prepare our students for a rapidly changing world, where technology plays a large role in our personal, social and professional lives.

Each student and a parent/carer will need to sign the agreement regarding student use of digital devices and online services including mobile phones.

Our objective with this policy is to promote greater independence, increased academic engagement, and a higher level of skill development for all students. Our goal is to prepare your child to connect, collaborate and compete as an ethical citizen in a future-focused learning environment.

CONSENT TO USE THIRD-PARTY SOFTWARE

Panania PS is committed to providing a technology-rich environment for our students. Our school community considers the use of information and communication technology to be fundamental in assisting teaching and learning in all areas of the school curriculum.

The school uses third-party software providers offering web-based online educational resources and cloud-based storage to support our administrative functions and enhance student learning outcomes.

In most instances, students are required to register before accessing the software. Registration involves either a staff member or student entering identifying information such as name, school year and the student's school email address into the software.
